1. Project description

Ingwe TVET college is requesting proposals from a service provider (s) for the provision of auctioneer services in Mt Frere, Lusikisiki, Bizana and Matatiele.

2. Project Background

The college has identified a number of moveable assets that are no longer useable in the college due to their condition, and therefore, a need to appoint an auctioneer to assist in the process of disposing these assets was decided. The college would like to appoint a registered professional service provider (s) to dispose the college's moveable assets.

3. Scope of work

Disposal of the following:

- 3.1 Computer Equipment
- 3.2 Furniture and Fittings
- 3.3 Other Equipment
- 3.4 Redundant vehicles including the college bus
- 3.5 Scrap metal

4. General Information

- 4.1 Auctioneer's commission or fee is payable by Ingwe college
- 4.2 No buyer's commission is to be charged by the auctioneer
- 4.3 The auction (s) will take place on a date (s) set by the college and the auctioneer
- 4.4 Auctions will be conducted in Mt Frere, Bizana, Lusikisiki and Matatiele

- 4.5 The college will make available a preliminary list of moveable assets to be auctioned before each auction.
